INWC President 2023

We are in search of an organized and motivated individual to become our Executive Director. The Executive Director of the INWC will oversee all operations, functions, and activities along with being the face and voice of the organization. The director will be responsible for providing strategies, direction, and implementation of the INWC's mission, vision, and goals as guided by the board of directors.

The Executive Director should show competency in managing, leading and motivating individuals and groups both in written and verbal communications. With these skills the Executive Director should lead the INWC towards its mission while taking action to expand its outreach and impact in the community.

Responsibilities

Provide continuity of programs and goals for the Council. This will be done through the following avenues:

Be responsible for organizing, managing, or overseeing all fund raising and promotional programs. This may include utilizing a fundraising committee and collaborating with other committees.

Work with the INWC treasurer and accounting firm to acquire understanding of the organization's financial and non-financial position and ensure regularly scheduled reports are available to the treasurer and secretary.

Be authorized to sign checks for legitimate Council expenditures.

Forge and maintain relations of trust with shareholders, partners, and external authorities and agencies that have an impact on conservation, hunting, fishing, wildlife, and habitat.

This will include the WDFW, the WDFW Commission and legislative activities that may impact the mission of the INWC.

This may include other organizations the INWC already has interactions with and organizations the Executive Director feels will have an impact on INWC activities.

Manage the business plans for the attainment of goals and objectives set by the board of directors.

Report on activities at each Board meeting and General meeting.

These reports may be in person or sent to the INWC President through email or printed copy. Reports should include updates on the Big Horn Outdoor Adventure Show (BHS) and any items concerning current INWC business.

Act as the public speaker and public relations representative of the INWC in ways that strengthen its profile.

Continued:

Be Chair of the Big Horn Show Committee. This will include:

- *Booth space marketing strategies
- *Coordination with venue and access of facilities
- *Collaborating with BHS committee chairs
- *Seeking new and building on existing sponsorships and establishing business agreements with those sponsors
- *Coordinate banking and financial processes for the BHS
- *Work with the INWC President to resolve issues that arise prior, during, or after the BHS.

The Executive Director will serve as the immediate supervisor of the Executive Secretary, following guidance laid out in the INWC bylaws.

The Executive Director will provide an annual evaluation of the work of the Executive Secretary to the INWC President and INWC board.

Ensure adherence of the organization's daily activities and long-term plans to established policies and legal guidelines.

Manage remedial actions for any identified issues involving the daily activities of the INWC office when necessary.

The Executive Director will meet with the INWC President and Executive Committee annually for the Executive Director's annual evaluation.

Requirements and skills

Experience with Microsoft programs, WordPress, and social media platforms.

Preferred experience managing/supervising along with developing strategies and plans to drive success.

Experience or the ability to fundraise and network, including but not limited to grant writing, banquets, raffles while ensuring compliance with all applicable governing bodies.

An understanding of hunting, fishing, wildlife management, and conservation. Using this knowledge and experience to communicate effectively during commission meetings or with other organizations.
